

# "On Wing" Juried Art Show

## Conditions for Entry:

"On Wing" is open to artists residing in King, Snohomish, Island, Jefferson and Kitsap Counties. All works must be original with bird theme, up to two entries per artist. Local delivery only; no shipped works.

## Entry Fee:

Maximum of two entries per artist. Acceptance fee of \$15 for one entry, \$25 for two. Each application must be accompanied by a check in the appropriate amount (fee will not apply to non-accepted entries; if two works are submitted, but only one accepted, difference in fee will be reimbursed). Applications without fee will not be judged.

## Jurying:

Works will be judged from digital images. Please include a PC compatible CD with images labeled using last name and title of entry. Two images maximum per entry (one overview and one detail, if needed). Your application must be accompanied by a self-addressed, stamped envelope for return of jury decision notice (and return of cd, if desired).

## Sales:

"On Wing" Juried Art Show charges a 15% commission on all sales. Sales Tax will be collected on all sales and remanded to artists for reporting.

## Insurance:

The Edmonds Conference Center will provide insurance on all art works exhibited in the show. Insurance value will be 85% of listed price. Consent to reproduce images for publicity or educational purposes is assumed, unless specifically reserved in writing. Submission of entry constitutes agreement to all conditions of prospectus.
